Dr. Mika Umpo, Registrar cum Secretary, APMC congratulated and welcomed the newly **elected, nominated and ex-officio members** to the 3<sup>rd</sup> regular Arunachal Pradesh Medical Council. Thereafter, Registrar cum Secretary, APMC highlighted achievements of the 2<sup>nd</sup> regular Arunachal Pradesh Medical Council as –

**(i) Stringent Actions against quacks & defaulters :-**

- One **fake doctor** Shri Rajendra Prasad Jaiswal tried to register with the Council was identified and accordingly arrested by the police as per the Council FIR.
- One Shri Gom Rinchin tried to register with **fake mark sheet of National Board Examination** of his foreign medical qualification was also identified by the Council. Action initiated against him as per rule. Later, his name was removed from Assam Medical Council where he had registered.
- One case of **Professional Misconduct** in respect of Dr. Sanjay Kumar Singh, SMO (SG) was received by the Council which was disposed off by the Ethical Committee, APMC with a warning for violating IMC (Professional Conduct, Etiquette & Ethics).
- **Joint Ethics committee** of all Councils of Health Department was constituted with the initiation of this Council to curve quackery in various forms with collective effort.

**(ii) Registration & practice issue:**

- **100% registration** of doctors in the state (including of Pvt. Institutions, TRIHMS, NHM & APHS) till Jan 2019.
- **Periodic notice for renewal** of Registration by registered members. **Late fee** as per APMC Rules.
- **Notice** to Doctors practicing without registration of basic qualification or additional qualifications.
- To make more **convenient for Doctors** for registration Council starts accepting registration fees as cheque.
- **APMC Registration No. & date of renewal mandatory** for APHS doctors to fill up ACR Form (now APAR).
- **Communication with Deputy Commissioners** of the District Administrations:-
  - DC, Upper Subansiri against **Lakhiram Basumatary**.
  - DC, Papumpare against **Rekib Ahmed**.

**(iii) Amendment of APMC Acts & Rules:-**

As adopted in the 5th Council meeting of 2nd Regular Council, the **Arunachal Pradesh Medical Council Act, 2004**; sub section (1) of section 4, for the existing entries in clauses (a), (b), (c) and sub section (2) was **amended** by GoAP by adopting in the State Assembly in 2017 to include DME, T&R and DFW as Ex-Officio member (in addition of

DHS) to the Council. To maintain the democratic nature of the Council 2 (two) more elected members have been included. **2nd Regular Council was reconstituted accordingly.**

(iv) **APMC Act and Rules Book reprinted** in which latest Amendment, CME Accreditation guidelines and other informations of APMC are included.

(v) **2 (Two) more Committees constituted:**

- The **Academic Committee, APMC** (Erstwhile Sub Committee on CME) for CME Accreditation and award of Credit points.
  - **The Committee (Act & Rules)** was constituted to examine and suggest amendment in the Act and Rules in future.
- The **Academic Committee, APMC** successfully framed CME Guidelines and accreditation policy which is now implemented in the State.  
And the present status is as :-
    - (a) Total CME proposal received =16
    - (b) Total CME proposal approved =15
    - (c) Total CME proposal rejected =01
    - (d) Total Empanelled organization: 01 (IMA-AP Branch).

(vi) Shri Chera Tullo (Legal advisor of the Deptt. of Health & F.W) to be utilized as the **legal advisor of the Council** w.e.f 15/10/2014.

(vii) In the 17th Council meeting held on 04/05/2016 the Council made it mandatory for all physicians /surgeons/experts in the field of modern medicine visiting the State of A.P from outside the State for the purpose of consultation invasive procedures etc to obtain **prior permission from APMC**. The application fee of Rs. 500/- is fixed for the purpose.

(viii) **Revamping of APMC Registration certificate format:**

- Initial issue date and valid upto on front page.
- Mail ID, Office Landline No., Website incorporated on the top.
- Registrar as Signatory of Registration certificate (instead of Registrar cum Secretary).
- Labeling of name on Registration certificate as per authentic documents

(ix) **Council Bhawan' for all Councils under one roof:-**

- Obtained mandate of all other Councils.
- The Committee under the Chairmanship of Dr. T. Lollen, SNO, CEA made spot verification of one the probable spot but found land not suitable for Council Bhawan.
- Therefore, the Committee recommends for Pachin in the proposed Medi-city of Health department. Application submitted to DME, T&R.

**(x) Council Official & staff issues**

- New Registrar cum Secretary joined: Dr. Mika Umpo joined APMC establishment on 17th November 2015.
- Created a unskilled Contingency post and appointed a new Contingency staff to assist the Council works.
- Approved 5% annual increment (from earlier no increment) to all APMC Staff.
- Re-designation of Liaison Personnel to Liaison Officer (from earlier Liaison Personnel) and re-fixation of Pay to Rs.30,000 per month @3% annual increment (from earlier Rs.19,060/- p.m with no increment).
- Timely identified the corrupt practice of Council Accountant cum Cashier shri (Late) N.C. Mazumdar. He was terminated from post w.e.f 1st Oct. 2018.
- Miss Kago Opi appointed as Accountant cum Cashier. Council's ratification to take effect.
