Dr. Mika Umpo, Registrar cum Secretary, APMC welcomed President and all members of Arunachal Pradesh Medical Council (APMC) to the 24th APMC meeting (3rd meeting of the 3rd Regular APMC). The Secretary, APMC informed the house that Dr. Emi Rumi, Vice President, APMC and Dr. Bombei Tayeng (Toko), Member, APMC telephonically communicated their inability to attend the meeting as Dr. Emi Rumi was out of station on personal ground, and Dr. Bombei Tayeng (Toko) was out of station on official duty. The President, APMC accepted the reasons of absence on the above circumstances. Thereafter, Registrar cum Secretary, APMC briefed the various activities taken up by APMC w.e.f 13th September, 2019 and action taken of the resolution adopted in 23rd A.P Council meeting as –

(A) Activities:-

 - iii 17/02/2020, Sub:-Sensitization Workshop on Pain & Palliative Care, Conducted by NHM in collaboration with Cancer Society of A.P .

- 1) Written complaint was received from IMA-AP branch regarding unauthorized stall of quacks near TRIHMS Gate.

Action taken:

- (a) Registrar cum Secretary intervened personally and requested Quacks to stop practice & leave.
- (b) When 'Quacks' continued to practice Registrar registered complaint against them to Deputy Commissioner CC and EAC, Naharlagun.
- (c) Actions were taken against them as per Magistrate Order vide No.EAC-Nlg/UD/1/2019, dt.03/12/2019 directing OC, Police Station Naharlagun to take action. Primitive medicines used by Quacks were ceased and evicted from the place with warning.

- 2) Complaint was received from IMA-AP branch against **Smt. Yanung Jamoh Lego, Deputy Director, Agriculture, Pasighat, A.P** on basis of viral videos in social media for misguiding patients with tall claims using unscientific way of medicine practice and used derogatory remarks against modern medicine practitioners.

Action taken:

- (i) The Registrar after obtaining approval of President APMC has written to Director of Agriculture seeking clarification if Agriculture graduates are allowed to Practice any form of medicine by any Govt. notification. And if not, Yanung Lego may be directed to desist from such practices.
- (ii) The Director Agriculture has clarified and warned Smt. Yanung Jamoh to refrain from use of abusive remarks against Modern Medicine practitioners.

(B) Action taken of the Resolution adopted in the 23rd A.P Council meeting as :-

- (i) Vide resolution Agenda Item No.3 adopted dated 13/09/2019, the contractual pay of Accountant cum Cashier, APMC has been kept in the pay slab of Rs.16000/- to Rs.25000/- and fixed @ Rs.16000/- (Rupees Sixteen Thousand) only per month w.e.f 1st October, 2019 and annual enhancement @ 5% of pay.
- (ii) Vide resolution Agenda Item No.4 adopted on 13/09/2019, the post of Unskilled Contingency was converted to MTS (Multi Tasking Staff) on contractual basis with fixed pay of Rs.11850/- (Rupees Eleven Thousand Eight Hundred Fifty) only and annual enhancement @5% of pay.
- (iii) Vide Agenda Item No.4 adopted dated 13/09/2019: Post-Creation under APMC.
 - (a) File No.APMC-65/2019 for creation of various Posts in Arunachal Pradesh Medical Council was processed.
 - (b) File returned from Secretary Health & FW with remarks to enclose similar post creation undertaken by State Medical Councils of North-East States.
 - (c) Matter is being taken up by the APMC Establishment.

Agenda Item No.3.

Decrease the minimum time duration of CME from existing 2 (two) hours to grant credit point to delegates and also to increase credit point system for different time duration: Motion moved by Chairman, Academic Committee, APMC- Prof. P. Jayakumar.

Prof. P. Jayakumar being the Chairman of the Academic Committee, APMC highlighted the reason for bringing the motion with an intention to encourage more participation of doctors to attend CMEs/ Workshop/ seminars etc to enhance their knowledge and skills in modern medicine. And in addition, he flag that some CMEs proposal received by the Academic Committee, APMC for examination to grant credit point were less than 2 hours where subject(s) matter for deliberation were of prime importance, whereas in the CME Guidelines of APMC the minimum duration is 2 (two) hours to consider proposal and grant 1 (one) credit point. Further, he mentioned that the numbers of CMEs conducted in the State are less. Therefore, he proposed to decrease the present minimum time duration of CME from 2 (two) hours to 1 (one) hour to grant credit point so that more number of CME proposals are considered for grant of credit point and also to increase credit point system.

The members discussed the matter at length, and after deliberation it was unanimously resolved that the present credit system for half day CME (less than 4 hours with atleast 2 hours of scientific session) with minimum two lectures , Half day CME (More than 4 hours), One day Conference, Two Day Conference and Three Day Conference be revised and refixed as below subject to amendment of APMC Guidelines for conducting CME Programme and Accreditation of CME Credit Hours :-

One Hour CME/Workshop/Seminars etc	– 1 Credit Point
Two Hours CME/Workshop/Seminars etc	– 2 Credit Points
Half Day CME/Workshop/Seminars etc	– 4 Credit Points
One Day CME/Workshop/Seminars etc	– 6 Credit Points
Two Day CME/Workshop/Seminars etc	– 8 Credit Points
Three Day CME/Workshop/Seminars etc	– 10 Credit Points

Further, it was also resolved that the CME Guidelines of APMC to be circulated again to the National Health Mission, A. P and all Vertical programmes of the Health Department of Arunachal Pradesh so to avail the credit points by attending doctors of the CMEs conducted by them.
